Terms and Conditions

<u>Delinquency Reporting:</u> NATIONWIDE will notify CUSTOMER whenever real property taxes as levied by the applicable County taxing agency are delinquent, at least on an annual basis. This information provided is obtained from County records and NATIONWIDE cannot be held responsible or liable for County accuracy. NATIONWIDE is not responsible for reporting Tax status on Contracts classified as Personal Property.

<u>Incorrect Information Reports:</u> NATIONWIDE will notify CUSTOMER whenever property information that the CUSTOMER provided is different than what is listed with the County, during the Tax reporting cycle. NATIONWIDE reserves the right to alter CUSTOMER supplied property information to match the County records or to delete the Contract if the discrepant information cannot be satisfactorily resolved. NATIONWIDE is not responsible for reporting Tax status on Contracts that appear on the Incorrect Information Report.

<u>Different Owner of Record Reports:</u> NATIONWIDE will notify CUSTOMER whenever a different Owner of Record appears on the County tax rolls, during the Tax reporting cycle. NATIONWIDE will make every attempt to verify the correct owner and may not flag situations where there is a likelihood of inclusion due to special circumstances (eg. <u>Delinquent Letter Service:</u> NATIONWIDE will notify CUSTOMER and Borrower of the Borrower's delinquent Tax status with the county, during the Tax reporting cycle. Delinquent Letter Service only applies to USA based mailing addresses. CUSTOMER is responsible for notifying NATIONWIDE with any changes in a Borrower's mailing address. Delinquent Letter Service is removed from all future reporting cycles due to returned mail from invalid mailing addresses. CUSTOMER has the choice of receiving both copies of the letter to mail at their own discretion.

<u>Impound/Escrow Services:</u> NATIONWIDE will provide CUSTOMER with tax bills or notices of real property taxes levied by the applicable County taxing agency, at least on an annual basis. CUSTOMER must follow the timeline/schedule set forth by NATIONWIDE.
